

## **Conemaugh Township Area SD (CTASD) 2022-23 Health and Safety Plan**

1. How will the LEA, to the greatest extent practicable, support prevention and mitigation policies in line with the most up-to-date guidance from the CDC for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning?

The health and safety of the Conemaugh Township Area School District (CTASD) and the staff and students remains the top priority for the organization. The CTASD Leadership Team and Board of School Directors will continue to take critical steps in making decisions that protect the health and safety of our organization in the ongoing response to the COVID-19 pandemic. During the summer months, cleaning and disinfecting of all areas of school buildings, grounds, and buses will be performed. These practices will prepare the school environment for a safe return of the students and staff. Cleaning supplies and equipment will be purchased for disinfecting against the COVID-19 virus. Cleaning, disinfecting, and ventilation protocols will be implemented daily and will include evening cleaning and regular disinfecting of all classrooms and common areas.

In response to the expiration of statewide mitigation orders, the CTASD has identified organizational standards and expectations which outline the protocols expected of all staff members as the organization transitions forward. Protocols include but are not limited to the following:

- Self-screening for COVID-19 symptoms
- Following communicable disease reporting procedures
- Practicing hand hygiene and respiratory etiquette
- Optional use of face coverings unless mandated by government orders.
- Maintaining physical distancing protocols to the maximum extent feasible
- Staying informed of CDC's guidance relative to travel
- Participating in required training
- Staying informed and maintaining best practices

These expectations are based on the latest mandates issued by the Governor's Office, the Pennsylvania Department of Health (DOH), the Pennsylvania Department of Education (PDE), the Department of Human Services (DHS), and the Centers for Disease Control and Prevention

(CDC). The CTASD Leadership Team will continue to monitor communications. As conditions change related to COVID-19, protocols are subject to change.

2. How will the LEA ensure continuity of services, including but not limited to services to address the students’ academic needs, and students’ and staff members’ social, emotional, mental health, and other needs, which may include student health and food services?

The CTASD plans to open the 2022-23 school year under pre-pandemic operating and educational conditions. The CTASD Leadership Team and Board of School Directors will continue to monitor COVID-19 conditions and follow any directives/orders of the Governor, State Legislature, PA DOH or CDC.
